# FY 11 Security, Stability & Resiliency Plan

- Detailed summary & analysis posted on 10 Nov
  - Most commenters generally supportive of the description of ICANN's role in SSR, but asked for clarification that ICANN not expand beyond its mission
  - Suggestions made to correct language, such as on Compliance, RPKI activities
  - Noted real need for system-wide analysis of risks and threats

# 2011-2014 Strategic Plan

- Updated the Strategic objectives for SSR:
  - Maintain & drive DNS uptime
  - Increase security of the overall systems of unique identifiers
  - Increase international participation in unique identifier security
  - Coordinate global DNS risk management



# SSR Observations

- Need better data –
  - Documenting of known risks
  - Documenting of current work to mitigate threats
  - Better understanding of systems and volume on the DNS
- Recommendations for DNS risk management models & metrics
- Collaborative models for DNS security
